## Cultural Assimilation and the Quest for Self in Ayad Akhtar's *American Dervish*

#### **Abstract**

This study approaches the themes of cultural assimilation and the negotiation of identity in Ayad Akhtar's *American Dervish*, locating the work in the vast discourse of diasporic literature. Within the contexts of modern literary and cultural studies, the fictions that Muslim-Americans have produced have become salient due to their ability to illuminate the complicated dynamics between religion, ethnicity, and national identity. However, despite the widening body of literature on the work of Akhtar, there is an ontological void in analyses that explore how internalized cultural contradictions shape the self-conception. Filling this void, the current paper investigates how the logic of American Dervish reveals the psychological and existential tensions that result from the demands of conforming to a secular, Western world.

Employing the techniques of qualitative literary analysis based on the close reading paradigm, the study utilizes identity studies to identify the moment of strain between conventional religious orthodoxy and the exigencies of modern America experienced by the protagonist. The novel offers a holistic insight into how the protagonist seeks to define himself as a Pakistani-American and the broader issue of American culture, while attempting to hold onto his Muslim identity amidst foreign conditions. #### 2. Literature Review

Cultural assimilation is an important and controversial area of study in the sphere of contemporary multicultural societies,

pertinent both to scholarly discourse and colloquial exchanges. As people live within spaces where prevailing cultural norms practice their influence subtly and overtly, assimilation becomes interwoven with questions of authority, inclusivity, and individual identity. Far from being a monolithic or linear process, assimilation operates in the framework of complex and contentious domains, in spaces where people willingly accept, repudiate, or reinterpret prevailing values of the assimilated culture. This literature review explores the dynamic theoretical perspectives of cultural assimilation, highlighting its conceptual nuances and examining its impact on identity formation, especially in diasporic communities. Focusing on Ayad Akhtar's American Dervish, the review observes how the protagonist's experience reflects wider theoretical dilemmas connected with cultural conformity, resistance, and incorporation. Through the intersection of sociological theory and narrative analysis, the review attempts to clarify the complex conflicts that emerge between the processes of assimilation and the formation of individual identity.

# 2.1. Definition and theoretical perspectives on cultural assimilation

Portes and Rumbaut (2001) posit that the process of cultural assimilation, in which individuals from diverse backgrounds are included into a larger culture, often requires or demands that alterations be made to people's modes of thought, action, and practice, such that these modes respect their own cultural background in favor of the dominant or host culture. Cultural assimilation is a complex phenomenon that means that in situations where individuals from diverse backgrounds are often pressured or compelled to assimilate to the practices or customs of the majority culture, it elementarily constitutes a process by which some aspects

of their ethnic identities are likely to be eroded and replaced with practice and customs of the host culture. The nuances of the debate about cultural assimilation are enriched by differences in perceptions, such that proponents maintain that cultural tolerance is fundamental to creating the conditions for appropriately assimilating those who must still develop a sense of identity. In contrast, opponents maintain that removing distinguishing features entirely is critical to effective assimilation. In this respect, assimilation is recognized as a particularly complex phenomenon extensively considered globally that engages several layers of complexity, including power, relations, cultural hegemony, and negotiation of the self.

Infante et al. (2020) note that in the process of interaction, there is a coexistence between the recognized customs of the host culture and recognized customs of minority culture or traditions, as the engagement and interaction between cultures through the process of assimilation continues to position both cultures so each culture evolves. This view suggests important implications for individuals and how to construct personal identity from intercultural experiences where individuals must negotiate intrapersonal conflicts and inter-personal conflicts in their conditions of reframing their own identity, and accommodating liberal acceptance of the traditional customs from another ethnoculture. It highlights the challenges and advantages of cultural amalgamation, noting that the loss of cultural heritage is one of the potential risks. The study deepens our understanding of literature that deals with multicultural themes and builds upon critical questions concerning the impact of assimilation on relationships and the journey of self-discovery. Thus, future studies may further explore the blending of identity within various contexts.

American Dervish by Ayad Akhtar explores the challenges associated with internalizing cultures other than one's own, as well as the formation of identity. This struggle by the protagonist to balance his cultural heritage with societal expectations raises excellent questions about how people navigate different cultural

backgrounds. The study illustrates how people struggle to integrate diverse cultures when examining the intricate details of the melting pot of norms in the story. # الاستيعاب الثقافي والبحث عن الذات في الدراويش الأمريكي لأياد أختر الملخص:

تتناول هذه الدراسة أبعاد الاستيعاب الثقافي واشكاليات الهوية كما تتجلى في رواية الدرويش الأمريكي للكاتب إياد أختر، من خلال مقاربة تحليلية نوعية تستند إلى التأمل النقدي والتفسير العميق لمسار بطل الرواية، حياة شاه، وهو يتنقل بين جذوره الإسلامية الباكستانية وضغوط الثقافة الأمريكية المهيمنة. تكشف الرواية عن تعقيدات التوتر بين الانتماء العائلي والضغوط المجتمعية وإغراءات الامتثال، مقدّمة الاستيعاب لا كفعل اندماج أحادي، بل كعملية تفاوضية تنطوي على صراعاً داخلياً ومجتمعياً حول الهوية العرقية والانتماء الثقافي.

تُفكك الورقة عدداً من الحقول الموضوعية المحورية، مثل أدوار الدين، وصراع الهوية، والجندر، وانعكاسات هذه العناصر على تماسك الأسرة والمجتمع وتجارب الاندماج في المهجر. كما تُظهر الرواية الآثار النفسية لهذا التداخل الثقافي، ممثلةً في مشاعر الاغتراب، والتمزق الوجداني، والتأمل الروحي، وكلها مجسدة عبر السرد الذاتي لتجربة حياة. وتؤكد الدراسة على مركزية التعاليم الدينية الإسلامية في تشكيل موقع حياة الاجتماعي والأخلاقي، مُقدِّمةً قراءة تؤطر الروحانية كجزء لا يتجزأ من عمليات التكيّف والتكامل.

وتستقصي الدراسة كذلك البعد اللغوي بوصفه عاملاً مزدوجاً: فهو من جهة يمكّن البطل من الانخراط الثقافي، ومن جهة أخرى يقيده عبر إعادة إنتاج توترات الهوية والانتماء. وتُبرز الرواية التفاعلات الجندرية وتوترات الأدوار الأسرية، مسلطة الضوء على فجوات الأجيال والصراعات الثقافية المتفاقمة التي تعيشها الشخصيات النسائية، لا سيما بطلة الرواية.

تُسهم الدراسة في النقاشات المعاصرة حول التعددية الثقافية، موضحةً كيف أن الهويات ليست ثابتة، بل يتم بناؤها ضمن شروط اجتماعية—تاريخية معقدة مدعومة بأمثلة من الأدبيات المعاصرة. وتخلص إلى الدعوة إلى مزيد من الدراسات التي تربط بين الدين واللغة والهوية في إطار أدبيات الهجرة، خصوصاً في ظل تصاعد تأثير العولمة على تكوين الذات في السياقات الحديثة.
