Nowadays, the arena of humanities is inseparable from arenas of the AI, or other economic, political and social values especially that all together contribute to the tapestry of the global human society that bred the United Nation's SDGs.

The fact is that future success will never rely on the non-human only, but rather on any advances honed by the humanities. The future path is a leap forward adopted by Tanwı̃r: A Journal of Arts and Humanities.

In this issue, the paper entitled "The Cycle of Life in Male Ritual Practices as Expression of Subversion and Identity in Ra'faat Al Dewiri's, Wiladah Mota'sira (Obstructed Labour) (1985)" explores how the cyclic rituals of life and death project the process of creative writing. The article investigates how the play presents ritual performances beyond festivities and social interaction. Technically, in the play, the function of rituals is mainly to criticize the 'unquestioned' through the writing process, linking literary creativity to cultural self-examination. Continuing with the theme of the human search for meaning through artistic and ecological expression, "An Ecopsychological Study of Darren Aronofsky's Film The Fountain" enriches the dialogue between film, mythology, and psychology by linking the 'Tree of Life' motif to humanity's quest for immortality. The paper offers a compelling perspective on how nature operates as a healing force within the human psyche, bridging ecological awareness and existential inquiry.

As technological innovation reshapes the creative and linguistic landscape, the paper entitled "Testing the Effectiveness of Prompt Engineering Technique in the Translation of CSIs using LLMs: Naguib Mahfouz's Midaq Alley (1947), a Case in Point" examines how LLMs handle the intricate task of translating culturally embedded expressions from Arabic into English. The study offers insights into the intersection of artificial intelligence and translation studies, particularly in preserving cultural authenticity and literary tone. It marks a significant step toward refining machine translation systems to balance semantic accuracy with cultural sensitivity in cross-linguistic contexts.

The issue also turns toward the theme of trauma and healing. "Adolescence Trauma and Posttraumatic Growth in Sara Barnard's Beautiful Broken Things and Fierce Fragile Hearts" examines how trauma and recovery shape adolescent identity and emotional

development. The paper offers an insightful exploration of the psychological journey from

victimization to empowerment, emphasizing resilience as a pathway to healing and self-

discovery in young adult fiction.

From literature and psychology to popular culture and sociology, "Afro Beats Lyrics and

Substance Usage among Juveniles in Warri City of Delta State, Nigeria" investigates the

relationship between popular music and youth attitudes toward drug use in Nigeria. The study

sheds light on how lyrical content in 'Afrobeat culture' shapes social behaviour and moral

perception among adolescents, calling for increased media literacy and educational initiatives

to counteract the normalization of substance use in youth entertainment spaces.

Concluding this issue, "Value Transformation in the Posthuman Era" presents an in-depth

exploration of how technological progress reshapes the structure of human values. Combining

theoretical and empirical analysis, the study reveals the impact of artificial intelligence, genetic

engineering, and the metaverse on redefining concepts such as dignity, freedom, and privacy.

The study offers a significant contribution to philosophical and ethical debates on the future of

values in a world where humanity and technology increasingly contend for the core of human

identity.
