1- The concept of national values for a nation:

We find that they are the characteristics of material objects and phenomena that characterize their importance for society, and material things represent types of values, because they are subjects of different human interests, material and spiritual. The artistic work is the subject of a human interest, as well as ideas represent a value that affirms the human will. In

addition to material, economic, spiritual and aesthetic values, there are cultural and historical values that make a subject for approval and disapproval, and the truth is that every society creates a certain set of concepts, ideals and principles, in order to guide On the basis of which the behavior of the people is regulated, and in most cases the conflict between ideology is at the same time a struggle between two systems of values.

other irregular, and also vary according to their presence and function That field performs, and we find that the breadth of the field depends on a number of factors, the most important of which are:

- 1- The field shape.
- 2- The height of the surrounding buildings.
- 3- The purpose for which it was established.
- 4- Street shows leading to it.
- 5- The relationship between it and the neighboring areas.
- 6- Traffic in the square and the breadth of the square also depends on the height of the surrounding buildings, as it is not possible to look at the front of the building and enjoy its architectural appearance except at a distance exceeding twice or twice and half the height of the building. - 3- The effect of sculptural works in public fields on rooting the meanings of national identity and values:

- 5- The role of the artistic vision in creating sculptural works bearing national values:
