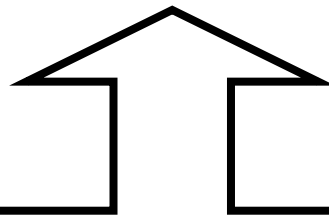

About the Journal

The Journal of Research in Education and Psychology is a quarterly scientific journal issued by the Faculty of Education, Minia University, since July 1987, and its publication is supervised by a group of education professors. The journal accepts research papers that have not previously been published in Arabic, English and French according to specific standards with accurate documentation of references. The Journal is concerned with publishing research in the field of education in all its branches and in educational psychology. The Journal is concerned with publishing research and studies in which the components of scientific research are available, including the originality of the idea, the methodology of scientific research, the characteristics and style of scientific writing in terms of accuracy, clarity and lack of verbiage. The journal also adopts the principles of the American Psychological Association (APA) in writing and documenting references.

All research published in the journal is subject to arbitration by specialized professors with high research experience in the subspecialty, and the arbitration process is conducted with transparency, accuracy and objectivity, and the research is reviewed by the editorial board until the research comes to light and has met the criteria for scientific publication.

It also has the feature of electronic arbitration and is indexed on the website of the Egyptian University Libraries Union and the Egyptian Knowledge Bank.



Aims and scope

Scope of the journal

The journal is concerned with publishing scientific research in the fields of educational psychology, fundamentals of education, curricula and teaching methods, tests and measures in educational statistics, mental health, social psychology, comparative education and educational management, education and community problems, curriculum development, growth and counseling psychology, technology Education, childhood, adolescence and youth education, special education for the gifted and the disabled, health and environment education, art education sciences, and all other subjects related to education and psychology.

Vision of the journal

A scientific journal classified internationally and a pioneer in the field of publishing distinguished educational and psychological researches.

Journal message

Providing a distinct container for publishing refereed scientific research in educational and psychological sciences to develop society and provide the necessary references for the scientific research process and service of researchers.



Journal goals

The Journal of Research in Education and Psychology aims to:

- Developing the educational community and educational institutions by publishing the results of peer-reviewed educational research.
- Providing a distinguished scientific publication base for publishing distinguished and well-controlled educational research by specialists.
- Meet the researchers' needs for the necessary research references for educational research.
- Contributing to the development of the local and regional community through the dissemination of educational research.
- Contributing to building social, cultural and educational values through educational research in this field.

Plan

- Inclusion of more prominent international scientific figures in the Editorial and Arbitration Board.
- Follow the latest developments regarding the scientific methodology and follow the rules of scientific writing, quotation ratios, and documenting references.
- Availability of the Journal on local and international databases, thus achieving its spread and distinction.



- **Developing the criteria for the scientific arbitration process so that it runs according to a more accurate and rigorous methodological plan.**
- **Providing accurate linguistic review services so that the research comes out free of linguistic errors.**
- **Adopting modern systems for presenting research results in terms of tables, graphs, and so on.**
- **The periodic review of the journal from all sides by a group of scientifically prominent personalities from outside the editorial and advisory body.**



Guide for authors

- The research is sent on the journal's website, and the search title is in the first page in PT Bold Heading, and the researcher's data is sent in Arabic and foreign languages in a separate document from the research.
- The search title tops the first page in PT Bold Heading, followed by the researcher's name and his job in brackets in light font, and it is taken into account that writing the title and the researcher's name are in the middle of the top of the page.
- Spaces are left not less than 3.5 cm to the left and right of the page, 3.5 cm to the top and bottom of the page, leaving a single space between the lines, and the type of writing in the body of the search is 14 Simplified Arabic, and the headlines are distinct from the body. The researcher provides two abstracts, one in Arabic and the other in English.
- The research should be taken into account to include the basic elements and the general framework of the research, especially the following steps:
A – Introduction and theoretical background.
B– Research procedures.



C– Statistical treatment (according to the nature of the research).

D – Discussion and interpretation of the results in light of the hypotheses.

E – Proposals and recommendations.

F– References (APA style).

● **Payment for publication as follows:**

A– 500 Egyptian pounds for the research of faculty members in the faculty within the limits of 20 pages, and 20 pounds are paid for each excess page.

B – 600 Egyptian pounds for research for researchers outside the college, the university and inside the country within the limits of 20 pages, and 30 pounds are paid for each excess page.

C – Payment is made in Egyptian pounds, equivalent to 300\$ for research for researchers from outside the country, within the limits of 20 pages, and \$ 10 is paid for each excess page after that (or against the price of the dollar in Egyptian pounds according to the market at the present time to the bank as a fixed price).

Payment is made in Egyptian pounds, equivalent to 200\$ for the research of faculty researchers abroad, within the limits of 20 pages, and five\$ is paid for each excess page.



E – The researcher submits an undertaking that he is present inside or outside the homeland.

- **When submitting his research for publication in the journal, the researcher affirms that it has never been published in another journal or conference, and is not submitted for publication for any journal or conference at the same time, and in the event of a violation, the researcher will be under penalty of law, and he bears the responsibility for that.**
- **The editorial board of the journal sends the papers submitted to two professors specializing in arbitration, provided that one of the arbitrators is from outside the university, and the papers are sent to the arbitrators for arbitration in secret, within 15 days of the date of the arbitrator's acceptance of arbitration, and the journal has the right to resort to another arbitrator in case of delay About the exact date.**
- **Research papers are published in the journal according to the priority of approval for publication after being prepared in its final form for publication.**
- **The author of the published research is given a copy of the number of the journal in which his research was published, and 10 copies of the paper.**



- **Research and studies express the opinion of its author and do not necessarily express the opinion of the journal. Responsibility for the opinions and the validity of the information and data contained therein and the references based on them fall on them personally.**
- **Everything that is published or accepted for publication in the journal may not be republished in any way of publication without the written permission of the journal management.**
- **The journal has the right to accept or refuse to publish any topics it receives.**



Publication ethics

The goal of scientific research is the advancement of societies and humanity, and this can only be achieved through adopting a set of ethics for research and scientific publication. The Journal of Research in Education and Psychology adopts all the ethics that would achieve the common good of societies and preserve intellectual property. Among these ethics are:

- Respecting intellectual property such as patents and copyrights, attributing opinions to their owners and avoiding plagiarism or theft.**
- Supporting social values related to human rights, respect for others, and differences of cultures and races.**
- Avoid racial discrimination based on gender, race or religion.**
- Accuracy in preparing research tools, data collection and analysis based on scientific basis that is not biased towards personal opinions.**
- The agreement of the means of scientific research with the principles of ethics, and that the end does not justify the means.**
- The scientific research and its outputs do not conflict with the ethical framework of societies.**
- Adherence to the laws and regulations established by institutions and bodies organizing scientific research.**



- **Respecting privacy, maintaining the confidentiality of information, and not using it except in the service of scientific research.**
- **Openness and cooperation in the field of scientific research and acceptance of constructive criticism.**
- **Commitment to social responsibility and striving to develop societies and solve their problems through research and scientific studies.**

Avoiding everything that harms the general interest of society or negatively affects its culture, form, and texture.

Avoid everything that harms people, whether material or moral harm.

- **Respect for the human self and not violating human rights and dignity when experimenting with it.**

Preventing any manipulation or exploitation to achieve personal interests and desires.

- **Preserving the cultural identity of the society, supporting public morals and contributing to building human civilization.**



Peer review process

- 1– Receive research**
- 2– Ensuring that the research is within the scope of the journal's goals**
- 3– Sending the research to two professors**
- 4– Deciding whether to publish or not in the light of the opinions of the arbitrators**
- 5– Making amendments, if any, by the researcher in the case of acceptance of publication**
- 6– Coordination of research according to publishing criteria in the journal**
- 7 – Determine the cost of publication and receive it on an official receipt**
- 8– Issuing a letter of acceptance of publication**
- 9– Follow up the printing and publishing process on the website**
